Basic ideas on risk measures in the framework of insurance premiums are also considered. The numerous exercises contained in *Modern Actuarial Risk Theory*, together with the hints for solving the more difficult ones and the numerical answers to many others, make the book useful as a textbook. Some important practical paradigms in insurance are presented in a way that is appealing to actuaries in their daily business. The mathematical background assumed is on a level such as acquired in the first stage of a bachelors program in quantitative economics or mathematical statistics.
